Application Processing:

When you return your application to the Waverly Gun Club, you must provide one of the following additional documents. Failure to do so will delay your application:

1. A Valid background check, that would include a permit to carry or a current permit to purchase. This is the applicant's responsibility to obtain from the local authorities.

Upon receiving your application, background check and NRA membership number, you can expect contact from the new membership committee and be required to attend a club meeting, held the first Monday each month at 6:30pm. At this meeting the current membership reserves the right to ask questions of the applicant in regards to their application to the Waverly Gun Club. The membership in attendance shall take a vote as to approve or disapprove the membership application. The Waverly Gun Club does not have to provide any reason for denying membership privileges.

Upon membership being granted the new member must attend Annual Safety Training in regards to the rules and regulations of the club and an orientation of the facilities and safe operation of the equipment. The new member signs their acknowledgment of the safety rules and regulations. This enables members to use the facilities. No use of the facilities are allowed until this training and orientation is completed. Your club access card will then be enabled allowing full access to the club house and shooting facilities.

Annual Dues and Fees:

Annual dues are considered past due if they are not postmarked by the first Monday in February. Payments received late will be assessed a ten-dollar (\$10.00) fee. Failure to do so will result in membership privileges being lost. You must then re-apply as a new member with new membership fees being applied. Initial fees are two hundred dollars (\$200.00) for the application, plus fifty dollars (\$50.00) as your initial annual dues. All fees are non-refundable.

Volunteer Work Hours:

Volunteer work hours are part of being a member. They are scheduled over the calendar year. Each member is responsible for a minimum of sixteen (16) hours per calendar year. If you are scheduled for work hours and are unable to attend it is your responsibility to find your own replacement to fill in for your scheduled work assignment. This can be accomplished through an email request through the membership email distribution list, or contacting your Work Assignment Captain for a paid replacement for a member or a student volunteer. The replacement is required to be in place within 24 hours of the scheduled work assignment. The current fine for not attending scheduled work hours is \$75.00 per 4-hour work assignment. Failure to pay the required fine will result in a temporary suspension of your club access card.

Violations:

Any violations of the Waverly Gun Club's rules and regulations in regards to firearm safety or use of its facilities may result in the loss of membership. These include but are not limited to the following; Failure to Sign-in for work assignment, firearm violations or unlawful use of a firearm, gun handling violations and too many guests shooting.
